AFAPA \$1000 STUDENT SCHOLARSHIPS

FREQUENTLY ASKED QUESTIONS ABOUT AFAPA STUDENT SCHOLARSHIPS

Who's eligible?

All graduating seniors & college-age (21 years old or less) children in care as well as birth and adopted children of foster parents or be adopted from Alabama DHR system are eligible to apply for an AFAPA scholarship.

Could the scholarship be used for trade school? Most definitely!

Can the funds be used for books?

Yes, the scholarship funds can be used for tuition, books, lab fees, or supplies purchased thorough the school account.

When should I apply?

The deadline for applications is March 1st each year. Please check afapa.org web site or call 1-888-545-2372

Do my grades matter?

AFAPA scholarships are not based on academic achievement. Rather, our review committee will be looking at each individual's needs and goals.

What if I decide not to attend school this year after I am granted the scholarship?

You would not be able to use the scholarship, you would be able to apply for another scholarship when you did start back to school if you are under age 22.

Where can I get an application?

Call the AFAPA office to have one mailed to you 1-888-545-2372. The applications are also on the www.afapa.org web site.

How long has AFAPA been awarding scholarships? The AFPA awarded its first two scholarships in the spring of 1999.

IMPORTANT THINGS TO KNOW ABOUT AFAPA SCHOLARSHIPS

If chosen to receive scholarship, provide proof of acceptance into a college/university/trade or vocational school is required along with student ID#

Submit application with (3) three letters of recommendation. Letters can be from foster parents, case workers, teachers, principals, guidance counselors, employers, pastors ect.

Please include a letter giving permission to publish name and photo if chosen for scholarship submitted with application.

On a separate sheet of paper include a brief statement of why you are applying for this scholarship. Include your hopes for the future and what you expect to contribute to society.

Be no older than 22 years of age at time of application deadline.

Unused portion or appropriate percentage of funds must be returned if recipient withdraws or does not report to school as scheduled. Applies also if student does not maintain grade point average required by institution to remain in school.

Scholarships funds are paid directly to the college/ university or vocational school and are deposited into students account. Funds are not paid directly to student and may not be used for personal items.

Scholarship funds may be used for tuition, maintenance fees, books, and or school supplies.

POLICY FOR SCHOLARSHIPS

Information should be place in Connections Newsletter closest to the beginning of the New Year. Deadline to be set by Scholarship Committee.

Scholarship Committee will collect applications and check for correct information. Attempts will be documented to contact students with missing or incorrect information .

A review committee reflecting diversity will be selected by the Scholarship Committee. Committee will use scoring sheets supplied by the Scholarship Committee to judge each application.

Scholarship Committee will then select winners.

All applicant names and contact information will be given to AFAPA Secretary. Secretary will send letter of congratulations or regrets to each applicant.

Time permitting winners names and pictures will be printed in the AFAPA conference brochure and Connections Newsletter.

Treasurer will send checks to appropriate schools after receiving information from students.

BILLS WOULD MAKE ADOPTION TAX CREDIT REFUNDABLE AGAIN

Since 2003, families who adopted a child with special needs from foster care could claim a federal adoption tax credit *even if they had no adoption expenses*. Children who receive adoption assistance/subsidy benefits are considered children with special needs. Other adoptive families are also eligible for the credit, but must have (and be able to document, if requested by the IRS) qualified adoption expenses.

The tax credit was refundable for 2010 and 2011, but is not for 2012 or 2013 or beyond. A refundable tax credit is one you get back regardless of what you owe or paid in taxes for the year. When the credit is not refundable, you receive only what you have in federal income tax liability.

In late May, bills to make the adoption tax credit refundable were introduced in both the Senate and the House. In the Senate, the Adoption tax Credit Refundability Act (S. 1056) was introduced and the House Bill, H.R. 2144 was introduced. The adoption tax credit was refundable in tax years 2010 and 2011, which meant that many more adoptive families were able to take advantage of it. If passed into law the Adoption Tax Credit Refundability Act would make the adoption tax credit an aid to lower and moderate income families as Congress originally intended when it created the credit.

We encourage you to ask your Representative and both of your Senators to become co-sponsors of this Act. We also suggest you share this information with others in the adoption community.

FOSTER CARE AND ADOPTION HOME REQUIREMENTS

Features in this newsletter are only a portion of the children that are available for adoption from Alabama's foster care system. You can see more children by visiting the following web sites www.heartgalleryalabama.com and www.dhr.alabama.gov (once on this page, click on "adoption", and go to the bottom of the page and click on "waiting children" and then click on "browse".) From the child or sib group's profile on these sites you can complete and submit an inquiry form. The inquiry forms are electronically transmitted to the staff with the recruitment response team that will respond and follow-up on the inquiries as indicated by your current home study/approval status. If you don't have access to the Internet, you may call 1-866-4AL-Kids (1-866-425-5437) and talk to a member of the recruitment response team.

We want you to know that these children are available for what is typically referred to as a "state-placed" adoption. Although changes to the foster family home approval policies this past year created a "foster family/ adoptive resource home" dual-approval status, families wishing to be considered for children not already placed in their home as foster children must have their home studies complete, current and approved by the State DHR Office of Permanency. If you are not sure if you have an approved adoptive home study on file with State DHR, you can call 1-866-4AL-Kids (1-866-425-5437) or send and e-mail to Familie4AKids@dhr.alabama.gov and ask a member of the recruitment response team to check on this for you.

FOSTER PARENT LICENSING REQUIREMENTS

- You must be 19 or older
- Criminal background checks are required for all household members 19 and older
- □ Clearance of State Central Registry on Child Abuse and Neglect for all household members 14 and older
- You must have family stability
- Statement from physician stating physically able to care for children
- Character references
- □ Regular source of income that meets your family's financial needs
- Successful completion of a home safety inspection
- Preparation training with homestudy and family assessment
- First Aid and CPR for adults, infants, and children
- If married, must be married at least one year (you do not have to be married)

ADOPTION LICENSING REQUIREMENTS

The State Office of Adoption may approve a policy exception to facilitate adoption in some cases.

- You must be 19 or older
- Criminal background checks are required for all household members 19 and older
- Clearance of State Central Registry on Child Abuse and Neglect for all household members 14 and older
- You must have family stability
- At least one parent must be United States citizen
- Reasonable good health as verified through completed medical forms;
- Character references
- Regular source of income that meets your family's financial needs
- Successful completion of a home safety inspection
- Preparation training with homestudy and family assessment
- First Aid and CPR for adults, infants, and children (for some kinds of adoption only)
- If married, applicants must be married for at least three years (you do not have to be married)
- **Costs to Foster and Adopt**
- Foster Families
- Assessment of a family's capacity to meet their own financial needs is a part of the homestudy process. The family will incur costs of medical examinations. Additionally, there may be a time, especially at the beginning of the foster process, when the foster family will have to spend their money to meet the needs of the child.
- Adoptive Families
- If a family is licensed to adopt through the Alabama Department of Human Resources, no fees are charged to parents who wish to adopt a child who is in foster care in Alabama or another State's foster care.
- Private agencies are also available to license families to adopt. Private agencies will probably charge fees. Please ask each individual agency if they charge fees.
- Fees are usual and customary for legal and court costs. These fees are assessed by the court and attorney.
- Families adopting children who qualify for a subsidy and are in foster care may be eligible for reimbursement of limited nonrecurring adoption-related costs, including legal and court costs. This would be available through the child's state or federal options.
- ☐ If your health plan or doctor charges you a fee when you receive the mandatory medical examination from your doctor, you will have to pay that fee to your health plan or doctor.

FOSTER CARE BOARD PAYMENT RATES.. TIME FOR AN INCREASE?

Comparing Foster Care Board Payments with Neighboring States

Foster Care board payments vary from state to state. In the year 2000 board payments in Alabama were one of the lowest in the nation at around \$240 a month. Though advocacy and working with State DHR, the legislature, and other child placing agencies board payments increased to more than \$400 a month over the next 2 years. In 2007 board payments increased by 75 cents per day to the current rates which are \$432 to \$468 a month depending on the age of the child. There has not been any type increase for the past 6 years. The following are rates in effect for 2010 in some of the surrounding states.

Florida \$429 to \$515 Georgia \$438 to \$564 Mississippi \$665 to \$837 Tennessee \$697 to \$818 Kentucky \$681 to \$741 Texas \$664 to \$1495 depending on difficulty of care

As you can see Alabama does rank at the bottom compared to our neighboring States. The big difference is the rate for caring for teenagers. So how much should the board payments be for Alabama? That is a hard question and depends on who you ask. We do hope that the Legislature will consider including an increase this year. It is time to let your senator or legislator know how you feel about this. Call or email them and I hope a few of them see this newsletter.



LOCAL FOSTER PARENT ASSOCIATIONS

Current Chapter members as of 10/28/2013 are Cullman, Cleburne, Chambers, St. Clair FAPA, and Houston.

- (C) Chapter Membership will be available to any foster and adoptive parent association in Alabama, approved by the Alabama Foster and Adoptive Parent Association board of directors. An association receiving chapter membership must operate in a consistent manner with the by-laws and constitution of the state association. Benefits to local associations receiving chapter membership include attending meetings, receiving all mailings, and the state association accepting tax-deductible contributions for the local association. All monetary contributions will go through the state association treasurer and ninety percent (90%) of the funds returning to the local association. The retained funds will be used for the purposes of the association as set forth in the by-laws and constitution of the Alabama Foster and Adoptive Parent Association, Inc. Guidelines and procedures will be provided to any qualified local association chapter membership. Chapter members do not have voting rights.
- (D) Chapter membership shall be a minimum of \$150.00 per twelve (12) consecutive months.

Section 3. Membership Year

The membership year shall be for a period of twelve (12) months concurrent with the accounting year.

All money that AFAPA receives from Chapter members is deposited in Scholarship fund and used for that purpose.

The renewal for Chapter members is October 1st each year and runs through September 30th of the following year. Chapter members are asked to submit a list of current officers, a budget, and current by laws for local association.
