RE: AFAPA Annual Conference

May 13, 14 & 15 at Shocco Springs

The Alabama Foster and Adoptive Parent Association will be hosting their annual conference for foster parents, adoptive parents and social workers. The conference is scheduled for May 13, 14 & 15, 2010 at Shocco Springs near Talladega, Alabama.

County staff are encouraged to attend. The Department will support mileage reimbursement for <u>one</u> car per county, so car pooling is encouraged. Should the larger counties identify the need for additional transportation, contact should be made with the Office of Permanency for individual approval. Staff should use RPT Category 439 on the travel form for mileage reimbursement. As part of the training is on a Saturday, any overtime earned must be flexed out according to policy. There will be no reimbursement for per diem approved. Registration fee, room and meals are paid by AFAPA. If a private room is desired, the employee may pay \$20.00. (This will <u>not</u> be reimbursed.)

Foster or adoptive providers who attend the training will be approved for reimbursement of mileage to be submitted through their local county office. They will be provided with a mileage form at the conference with the RPT Cat. 439. Conference mileage must be submitted on this form.
